I am directed to state that the Board of Governors at its meeting held on 30.01.2019 considered the Assessment Report (10.05.2018) on the standard of examination and other teaching facilities available at Sri Venkateswara Medical College, Hospital & Research Centre, Pondicherry for purpose of Recognition of MD(General Medicine) qualification for 02 seats granted by Pondicherry University, Puducherry and decided as under: -

"The Board of Governors considered the Council Assessor's Report (10.05.2018) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(General Medicine) qualification for 02 seats granted by Pondicherry University, Puducherry in respect of students being trained at Sri Venkateswara Medical College, Hospital & Research Centre, Pondicherry be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
