## <u>Sri Venkateshwaraa Medical College Hospital & Research Centre (SVMCH&RC):</u>

Sri Venkateshwaraa Medical College Hospital & Research Centre was established by Ramachandra Educational Trust in the year 2007 as a non-profit self-financing Telugu minority institution providing high class facilities and services in all specialties and super specialties and providing "state of the art" equipment / facilities to enable the Doctors to utilize their skills and expertise for the benefit of the people. Create excellent infrastructures for medical education and right atmosphere to study.

Medical Council of India has renewal of the recognition of the MBBS Degree in August 2018 with annual intake of 150 Students per year vide Gazette Notification order No. No. MCI-34(41)(UG)/2017–Med/127267, dated 2<sup>nd</sup> August, 2018, Ministry of Health Welfare, (Department of Health and Family Welfare) New Delhi.

#### 1. ELIGIBILITY FOR ADMISSION TO MBBS DEGREE COURSE

- a) Candidates of Union Territory of Puducherry are eligible for Government Sponsoring candidates.
- b) Candidates belonging to any State / Union Territory of India are eligible for Management Quota/NRI Quota.
- c) Every candidate must possess the prescribed qualifications and fulfill all criteria prescribed by the MCI, at the time of joining the course.
- d) Candidates must have studied in a recognized School and passed HSC, (+2) examination / equivalent examination and obtained a minimum of 50% of marks (in case of SC/ST & OBC 40%) taking together Physics, Chemistry and Biology (or Botany & Zoology) / Biotechnology and a pass in English.
- e) As per orders of the Hon'ble Supreme Court, in order to be eligible for admission to MBBS Course for the academic year, it shall be necessary for a candidate to have appeared and obtained the prescribed marks in the National Eligibility-cum-Entrance Test (NEET(UG)-2020).

Note: Mere appearance in NEET UG 2020 does not confer any right to the candidate for admission in MBBS Course. The selection and admission of candidates to MBBS course in Sri Venkateshwaraa Medical College Hospital & Research Centre is subject to fulfilling the admission criteria, eligibility, All India rank in NEET UG-2020 merit list, medical fitness and such other criteria as may be prescribed by the Government of India, MCI and rules and regulations of the Management.

#### 2. AGE LIMIT:

Candidates should have completed 17 years of age as on 31<sup>st</sup> December, 2020, Date of birth entered in the Mark Statement of HSC/CBSE/ISC or its equivalent Examinations or in the Birth Certificate of Passport shall be taken for computing the age of the candidates.

#### 4. HOW TO APPLY:

#### **CENTAC:**

Government of Puducherry has authorized the CENTAC to conduct the admission procedure for admission to the MBBS Course for the academic year 2020-21.

- The online registration process for admission of students to MBBS courses for the year 2020-21 will be done by CENTAC.
- CENTAC will conduct counseling for admission of candidates in MBBS Course for the seats available in Medical Colleges.
- CENTAC will conduct common counseling for admission of candidates in MBBS Course in respect of seats allocated for Government Quota in Private Medical Colleges. CENTAC will conduct common counseling for admission of candidates in MBBS Courses in respect of seats allocated for Management Quota (including minority quota, if any) in Private Medical Colleges.

Candidates should apply online application in the CENTAC website www.centacpuducherry.in.

Before filling the application, read the online prospectus carefully.

## Candidates should ensure the following instructions:

Candidates should register the online application using the email Id and fill in their NEET-UG Roll number, which will pre fetch essential data relating to NEET score.

Candidates should upload scanned self-attested photo copies of the necessary certificates, in support of different claims. Original certificates must be produced only at the time of admission in the respective colleges.

All the certificates to be produced for various claims should be obtained and updated from the respective competent authorities and have the stipulated validity time.

A community certificate issued by Govt. of Puducherry will only be considered for claiming reservation benefits under Govt. Quota.

Minority Certificate (Telugu Speaking) issued by the concerned State Governments (except Andhara/Telegana States)/in the Transfer Certificate mentioned as Mother Tongue will only be considered for claiming the Minority (Telugu Speaking) quota.

Sports Quota certificates must be countersigned by the concerned authorities.

## **Guidelines for NRI/NRI Sponsored /OCI admission are as follows:**

- An NRI student is one who has NRI status. Students who have studied their qualifying exam equivalent to 10+2 of India, form schools or colleges abroad (outside India) will also be considered as NRI student.
- Candidates should fulfill the minimum eligibility criteria to seek admission under Non resident Indians (NRI) category.

Candidates may login and fill their personal details along with course preferences. Only after making payment of application fees (nonrefundable) is made, the students will be allowed to enter their preference of courses. Without preference, the application will be incomplete and will be summarily rejected. Candidates should bear in mind that the allotment of seats will be made based on preferences of subject to the availability as per merit and reservation. Candidates are allowed to modify till the last date of application. Candidates should opt the choices carefully.

Once choices of courses are made, they are final. However, CENTAC reserves the right to permit all the students to alter the preferences for the subsequent rounds of Counselling.

Options once exercised with regard to community / special categories are final and cannot be changed once the FINAL merit list is published.

Further intimation and communication will be through SMS, E-mail & updates in the CENTAC website apart from publishing the same in the public media by way of press releases. After the online admission date is announced the students should refer to the CENTAC website <a href="https://www.centacpuducherry.in">www.centacpuducherry.in</a> regularly, for updates. Candidates are requested to ensure that their phone number and email are valid and check the same regularly on a daily basis in their own interest.

- The counseling in respect of MBBS Course will be done for-
- Category 1 Seats in Government Medical Colleges
- Category 2 Government quota seats in Private Medical Colleges
- Category 3 Management Quota seats in Private Medical Colleges. This includes minority quota seats in PIMS and SVMC.
- Category 4 NRI Quota seats in Private Medical Colleges.
- For Category 1 and 2 seats only the residents of UT of Puducherry are eligible and the reservation norms apply. For Category 3, i.e., Management Quota seats in Minority Colleges (PIMS and SVMC) for the first 2 rounds only the minority candidates who are resident of the UT of Puducherry will be eligible.

#### **IMPORTANT NOTE:**

- a) All admissions are subject to fulfillment of all the eligibility conditions by the candidate. If it is found at a later stage, that the candidate has given false information/forged certificates or concealed material information, his/her admission will be cancelled without any notice.
- b) **DEPOSIT OF CERTIFICTES**: Verification of originals certificates will be made at the time of admission. Candidates provisionally selected for admission will have to deposit all required original certificates with the college office. Therefore, candidates are advised to keep with them adequate number of attested photocopies of their certificates.

The candidate should submit the following certificates in original alongwith two Xerox copies:

#### 6. CHANGE OF NAME/DATE OF BIRTH:

The name and date of birth of candidates will be registered in the records of the University as given in their H.S.C. Mark Statement/Transfer Certificate only. No request will be considered later in regard to corrections in the spelling of the name of the candidates. The parents and candidates are requested to verify and confirm these entries in the H.S.C. Mark Statement/Transfer Certificate at the time of receipt of the same. Once admitted to a course of study in the college, date of birth as furnished in the H.S.C./School record of student and submitted to the college at the time of admission, shall be taken as final proof and no subsequent request for change of date of birth will be entertained by the college at any time under any circumstance, either during the course of study or after the completion of study. Every students shall give an undertaking to this effect duly countersigned by his/her parent of guardian at the time of admission.

#### 8. RULES FOR DISCONTINUANCE FROM COURSE OF STUDY

- (i) Where any students applies for discontinuance, or without any application discontinues on his/her own, from the course to which he/she has been admitted to, for any reasons, either after the cut-off date prescribed by the statutory authorities for admission to the first year of the course concerned or where the seat is rendered vacant without having any change of being filled up with any other candidate from waiting list etc., such students will have to remit the tuition fee and other applicable fee for the 'entire / remaining course period '. Unless and until payment of all the prescribed fees for the entire/remaining period is made to the college account, such student shall not be entitled to any certificate including transfer certificate, mark sheets etc., to be issued by the College and get back his/her original certificates deposited with the College at the time of admission.
- (ii) All students and parents will be required to furnish a declaration agreeing to the above said conditions at the time of admission.

#### 9. ATTACHMENTS:

The candidate should submit the following certificates attested by the Gazetted Officer / Head of the institution where the student has studied along with the application.

- (i) Photo (same photo as in the NEET admit card)
- (ii) Provisional Admit card NEET (UG) I/II 2016
- (iii) NEET (UG) 2016 Percentile Score / All India Overall Rank card
- (iv) Copy of 12<sup>th</sup> Std Mark statement
- (v) Proof of Date of Birth.
- (vi) Transfer Certificate.

### **REGULATION FOR MBBS COURSE:**

As per the revised regulations of the Medical Council of India, every student, who is admitted to MBBS Course shall undergo a period of certified study extending over 4½ academic years starting from August of every year and after completing 4½ years (i.e., ended with Feb.) of his/her study for the subjects comprising the medical curriculum to the date of completion of examination and followed by one year Compulsory rotating Internship.

## (a) First Professional

- 1. The first Professional examination shall be held at the end of first Professional Training (1+12 months), in the subjects of Human Anatomy, Physiology and Biochemistry.
- 2. A maximum number of four permissible attempts would be available to clear the first Professional University examination, whereby the first Professional course will have to be cleared within **4 years** of admission to the said course. Partial attendance at any University examination shall be counted as an availed attempt. Registering for an University examination is considered as an attempt irrespective of appearance for the examination. A candidate cannot register in part or separately in individual subjects during the first appearance at the Professional Examination.

## (b) Second Professional

1. The second Professional examination shall be held at the end of second professional training (11 months), in the subjects of Pathology, Microbiology, and Pharmacology.

## (c) Third Professional

- 1. Third Professional Part I shall be held at end of third Professional part 1 of training (12 months) in the subjects of Ophthalmology, Otorhinolaryngology, Community Medicine, Forensic Medicine and Toxicology
- 2. Third Professional Part II (Final Professional) examination shall be at the end of training (14 months, including 2 months of electives) in the subjects of General Medicine, General Surgery, Obstetrics & Gynaecology and Pediatrics. The discipline of Orthopedics, Anaesthesiology, Dentistry and Radiodiagnosis will constitute 25% of the total theory marks incorporated as a separate section in paper II of General Surgery.

The discipline of Psychiatry and Dermatology, Venereology and Leprosy (DVL), Respiratory Medicine including Tuberculosis will constitute 25% of the total theory marks in General Medicine incorporated as a separate section in paper II of General Medicine.

#### **FACILITIES AVAILABLE FOR STUDENTS**

- i) Research activity: SVMCH&RC supports an active research programme to enable all UG students to broaden their experience, encouraged to participate in research activities with funding from both intramural and ICMR (STS) being made available to them.
- ii) **Extra Curricular Activities**: Facilities for games and sports are available in the campus. All UG students are permitted and encouraged to use these facilities.
- iii) **Students/Staff Health Clinic**: The medical needs of the students and staff of SVMCH&RC are met through the clinic provided for this purpose. Hepatitis B Vaccination is mandatory for all UG students.

## 11. ATTENDANCE:

A minimum of 80% attendance in each academic year is compulsory. Students availing long leave will be able to appear for the examination only after additional six months/ one year.

Those students who are required to do extended durations will have to pay the additional fees.

Those students who miss University Examinations can appear only in the next University Examinations, which will normally be held within six months from the date of the earlier examination or as per specific directives of the Medical Council of India and Dental Council of India.

#### DISCIPLINE:

- 1. Rules and regulations as prescribed should be strictly followed at the college, hospital and hostels
- 2. Smoking and alcoholic drinks are strictly prohibited in the hostel and campus.
- 3. Dress code: It is mandatory for the students to dress up neatly and decently in pants and shirts with shoes for boys and salwar kameez/ chudidar with sandak for girls. Jeans, Baggies, T-shirts, and the likes are not permitted to be worn inside the hospital/ college during duty hours.
- 4. UG students should have Identity card while in the class or in OPD
- 5. UG students should wear white apron while in the OPD and wards
- 6. Indulging in group activities / canvassing for or against any political, ethnic, social, cultural or religious groups are not permitted inside the campus.
- 7. Students should not get involved in illegal or immoral activities in the institute premises. Action as per law will be taken against them.
- 8. UG students are expected to observe discipline in their conduct during the entire period they spend in the institution. Failure to observe absolute discipline will invite appropriate disciplinary action.
- 9. **Ragging is strictly prohibited.** If found during the admission or any time there after that the applicant has indulged in ragging in the past, admission may be refused or the student shall be expelled from the institution. Whoever commits, participate in abets or propagate ragging within or outside the institution shall be suspended from the institution with immediate effect and the Principal shall report the matter to the civil/ police authorities
- 10. Rules & Regulations of the Hostel have to be strictly followed. The timings have to be strictly adhered to. No vehicles are permitted in the Hostels.
