Key meeting activities

- The Dean and Chairperson of IQAC, Dr. S.Ratnasamygave the welcome address to the IQAC members and to the special invitees Dr. Muthukumaravel and Dr.A.Mangaiarkarasi, Vice principals of SVMCH.
- The reconstitution of IQAC was discussed. The Chairperson included the Vice Principals Dr.
 Muthukumaravel and Dr.A.Mangaiarkarasi in the cell and suggested replacement of Dr. BindhuMenon,
 Associate Professor of Psychiatry with Dr. Madhan, Assistant Professor of Psychiatry.
- Mr. Gnanasegaran, Advocate (Stakeholder) suggested the replacement of the Industrialist Mr. Vigneshas
 he had shifted out of Puducherry.
- Dr.Suresh, Deputy Medical Superintendent, who was added as a teacher in the IQAC was decided to be included as Senior Administrative Officer. Mr.N.R.Pugazhenti who has been included local societymember was decided to be included as part of Management.
- The Chairperson, Dr. Mahadevan (Dean Pg and Research), Mr. Gnanasegaran opined that anybody from Small scale industries of Ariyur can be included as Industrialist and a school headmaster or anyone in that cadre can be included as Local society member.

- Suggestions on whom to add as members of local society member and Industrialist were asked fr.
 Mr.N.R.Pugahenti and Mr.A.Soundararajan. They have told that they will discuss and finalize the n.
 members.
- The list of existing 31 committees were read out by Dr.Suresh (Co-ordinator of IQAC). The Chairperson, suggested that the 31 committees can be headed by Dr.Suresh, Deputy Medical Superintendent and the Vice Principals Dr. Muthukumaravel and Dr.A.Mangaiarkarasi. They can overview the work done by the committees and check if Standard operating Procedures has been created. They shall also rerview the past academic events like Agenda, Minutes of meetings and Action taken reports of the respective committees are maintained properly. Dr. Latha, Prof of Physiology suggested that an academic calendar can be prepared with dates of meetings of various committees, so that meetings are conducted regularly without any delay.
- The Chairperson accepted to it and asked Dr.Latha to start organizing the same.
- The Chairperson informed the members that Dr.Sakthibalan, Associate Professor of Pharmacology, who
 was assigned to present the feedback analysis, was not able to make the presentation due to some personal
 reasons and he shall make a presentation in June 2021 when the NABL inspection is expected.
- The Chairperson asked for opinion on Topics of quality related workshops and research related workshops that can be organized by SVMCH.
- Dr.Suresh (Co-ordinator of IQAC) opined that the Quality related workshop can by one Institutional Best
 Practices, Administrative workshops for Office non teaching staff and NAAC related or ISO related
 Workshops. Dr. Mahadevan said it would be very helpful for the faculty if Non teaching staff are trained.
 Dr. Surendar, Associate Professor of Community Medicine said Quality related workshops can be
 conducted for the community under the topics of Environment and Health awareness.
- Dr. Mangaiarkarasi opined that few Quality related workshops with regard to Pharmacology also can be conducted.
- Dean sir and Dr. Mahadevan informed that they will talk with the Chairman on increasing the grant amount towards journal charges in indexed national and international journals.
- Dr. Mahadevan opined that since Dr. S.S.Rajasekar, President of Institution Innovation Council of SVMCH will be able to give better ideas in this regard.
- The Chairperson asked the Co-Ordinatior to invite Dr. Rajasekar as a Special Invitee to the next IQAC
 meeting so that he can present his views in this regard.
- Discussion on paper publications of teaching faculty was opened and the minimum number of publications
 yearly for each faculty were asked by Chairperson. Dr. Subashree, Assistant Co-Ordinator of IQAC said
 that according to NAAC there is no prescribed criteria as minimum number butatleast two should be made
 by each faculty each year for good rankings in NAAC.

Dr.Latha made it a point that only those which were SCOPUS, Web of Science, UGC care will be accepted. The process of collection of articles published by faculty in the indexed journals has already started from the year 2015-2020 has already started. The Chairperson asked Dr.Latha to fasten the process with the HODs and DEOs of individual departments.

- The Workshops/ Conferences / CMEs to be organized by each department was emphasized.
- The Chairperson insisted that frequently state level conferences should be conducted in SVMCH.
- The Chairperson concluded the meeting.
