1. This agreement will be valid from 01st April 2025 to 31st March 2026 for a period of one year.
2. The agreement stands valid for the below mentioned services only and for the period as mentioned in clause 1.
3. Pre / Post Employment Medical Health check-up will be done for all the employees at Caplin Point Laboratories Ltd at the cost of Rs.700/- per person. The charges mentioned will apply only for services covered in annexure I. Any additional diagnostic/therapeutic exercise which is required as a result of above-mentioned health check-up shall be chargeable separately on case-to-case basis.
4. An Eye check-up will be conducted once every six months for all the staff members at the cost of Rs.100/- per person.
5. The persons we send to your hospital for pre-employment medical examination shall be medically examined by a competent medical officer and provide a certificate and medical examination report that the employee is fit for work.
6. SVMCH & RC will conduct the Annual health check-up at M/S. Caplin Point Laboratories Limited as per scheduled date, which shall be mutually agreed by both the parties, with adequate medical devices, equipment's, materials and manpower.
7. All the staff members will do Annual medical check-up in the factory premises on the scheduled date. Blood and Urine samples collected from the employees will be transported to SVMCH & RC facility for reporting, and remaining health check-up will be done at the Premises.
