2. SVMCH & RC can organize and conduct Health Campus, Health checkups, and Health education programmes for the employees of Zenomed Healthcare Pvt ltd situated in Navamalkapper, Viluppuram with the consent of the management of Zenomed Healthcare Pvt ltd.
3. Lab Charges for Health Check will be per the annexure.
4. SVMCH & RC will charge nominal fair for any minor or major accident of Zenomed Healthcare Pvt ltd employees as case to case as per the requirement.
5. SVMCH & RC can sub-contract certain medical service pertaining to the health of the employees to other agencies of found necessary, with the consent of Zenomed Healthcare Pvt ltd.
6. SVMCH & RC at its discretion can transfer patients to other hospitals for higher management or medical investigations if such a need arises.
7. SVMCH & RC and Zenomed Healthcare Pvt ltd personnel will be abiding by the rules and regulations mutually agreed upon. Any breach of the same shall be brought to the notice of SVMCH & RC or Zenomed Healthcare Pvt ltd management, as the case may be and there shall be no direct conflict with the concerned employee.
8. In case of emergencies, the concerned Zenomed Healthcare Pvt ltd employee will have to produce the authorization letter within 24 hours to SVMCH & RC.

12. Neither party shall transfer its rights or obligations in any manner what so ever without the prior consent of the other.


