



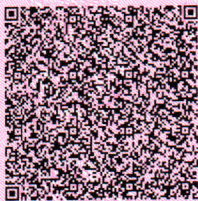

Both the parties do hereby agree as follows:

This MOU is valid from **01.11.2025 to 31.10.2026**

1. SVMCH&RC agrees to provide all diagnostic services, surgeries and other procedures both as OP, IP and during emergencies to the employees of WPPL situated in R.S.NO.333-2A & 2B2, Navamal Marutur Village, Kandamangalam Block, Villupuram Dist, Tamil Nadu – 605 102, of this MOU (revised usually on the first day of every November)
2. SVMCH&RC agree to organize and conduct Health Camps, Health Checkup, Health education programmes for the employees of WPPL situated in R.S.NO.333-2A & 2B2, Navamal Marutur Village, Kandamangalam Block, Villupuram Dist, Tamil Nadu – 605 102 with the consent of the management of WPPL.
3. SVMCH&RC will charge nominal fare for any minor or major accident of WPPL employees on case to case basis as per the requirement.
4. SVMCH&RC can sub-contract medical service pertaining of the employees to other agencies if found necessary, with the consent of WPPL.
5. SVMCH&RC at its discretion can transfer patients to other hospitals for higher management or medical investigations if such a need arises.

SVMCH&RC agrees and conduct Health checkup includes of all Tests like Height, Weight, BP, BMI, Blood Glucose R, Urine Routine, Total Cholesterol, Pulmonary Function Test, Audiometry Test, ECG, Vision Test, Dental checkup, Chest X-ray, Skin Examination, Cardiac checkup & screening etc., Along with Doctor Consultation& Registration with mutual agreed price.

7. SVMCH&RC also agrees to conduct a medical examination of newly joined employees of WPPL with mutual agreed price.

8. SVMCH&RC and WPPL personnel will be abiding by the rules and regulations mutually agreed upon. Any breach of the same shall be brought to the notice of SVMCH&RC and Sri Venkateshwaraa Dental College or WPPL management as the case may be and there shall be no direct conflict with the concerned employee.

9. In case of emergencies, the concerned WPPL employee will have to produce the authorization letter within 24 hours to SVMCH&RC and Sri Venkateshwaraa Dental College.

10. Ambulance will be provided by SVMCH&RC to pick up patients during emergencies from WPPL in R.S.NO.333-2A & 2B2, Navamal Marutur Village, Kandamangalam Block, Villupuram Dist, Tamil Nadu – 605 102 to SVMCH&RC at a nominal rate.

11. SVMCH&RC will submit the bills towards the medical services to WPPL by the first week of the following month, payment can be made by way of Cheque/Demand Draft/ NEFT and online payment methods within 15 days of receipt of bill.

12. This MOU shall come into force from the date hereof, Either party may terminate this MOU upon 30 days notice writing to the other party, provide in the event of material breach by either party of the terms hereof, the other party may terminate this MOU with immediate effect.

13. Neither party shall transfer its right or obligations in any manner whatsoever without the prior consent of the other.

14. The parties agree that the terms and conditions of this MOU are confidential and shall not be disclosed to any third party without prior written consent from the non-disclosing party, unless such disclosure is required in the court of law.

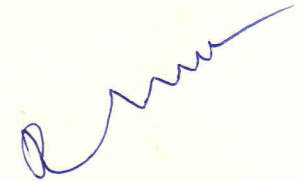
